- 3. **Limits on Confidential Information:** Confidential Information shall not be deemed proprietary and the Recipients shall have no obligations with respect to such information where the information:
 - a. Was known to Recipient prior to receiving any of the Confidential Information from Disclosure;
 - b. Has become publicly known through no wrongful act of Recipient;

- c. Was independently developed by Recipient without use of the Confidential Information: or
- d. Was ordered to be publicly released by the requirement of a government agency.
- 4. **Ownership of Confidential Information:** Recipient agrees that all Confidential Information shall remain the property of Discloser may use such Confidential Information for any purpose without obligation to Recipient.
